1. I can confirm that I meet entry requirements set out above.
2. I can confirm that I fully understand that the Miss Tallafesta trademarks and logos belong to CCI, Inc.
3. I understand that CCI will pay for my accommodation and meals. I understand I can be required to share a room with other contestants.

I understand that any other expenses such as ironing, laundry, dry cleaning, telephone calls, telegrams, telexes, e-mails, postcards, stamps, drinks, and all other personal expenses are my responsibility and must be paid for by myself upon receipt of the invoice. I also understand that I am responsible for any excess luggage fees incurred from traveling.

4. I understand for my own safety that I will be chaperoned. I agree that I must not accept any invitation from anyone who is not part of CCI, be it for dancing or any entertainment. I also agree never to give out my personal phone number or email address. This is so you can insure that I have a safe and memorable trip. I accept the schedule of events established by the organizers throughout the competition and agree to abide by them fully.
5. I agree to behave with dignity and be polite to my hosts, their guests, and competitors.
6. I accept that the judging will take place during the swimwear and evening wear sections of the final competition and knowing the impartiality of the judges, I accept the results. I agree not to protest against the final result and will not make any comment about it or offer my personal opinions to the press or any other person at the competition.
7. I will include my the wardrobe for the competition:

- 1 long evening dress
- 1 National costume
- 1 Bikini

8. Although I will bring my own swimsuit , I understand that if a sponsor should request that I wear their swimsuit, I will not object. I understand that I will not be able to wear my own if a sponsor should make a request.
9. I authorize the use of my photograph, name, and film footage for use on television, the internet, and promotional use via whichever medium CCI chooses to employ.
10. I authorize the right to place images and film footage of my online for any purpose and in any territory at CCI's discretion.
11. I confirm that I will not be involved in ambiguous photographs or events. I will not be involved with any photographs or materials that could compromise my position.
12. If I am elected the winner, during my year of reign, I will abide by the rules and conditions set out in this contract. I also agree to stay on after my crowing for further days if I am required to assist at receptions or promotional work.
13. If I am the elected the winner, I agree that I will not sign any agreement, contract, picture or declaration without the prior written agreement of CCI. I also agree to inform CCI of proposals of travel well 30 days in advance.
14. If I am elected the winner, I agree not to compete in any other contest for one year from the beginning of my election.
15. If I am elected the winner, I agree to sign a modeling contract with CCI for a minimum of one year beginning with my election.
16. I understand failure to comply with the terms set out in this agreement will grant CCI the right to terminate this agreement and to nominate the First runner up as the new winner. Such action will allow the new Miss Tallafesta all rights and corresponding obligations. I agree upon my release as the winner, the use of the title and any claim will be prohibited and shall return all items to CCI.
17. I agree to attend the final competition the following year in order to crown the new winner.
18. Exceptional Circumstances.

Under no circumstances such alteration shall be interpreted as a waiver of the obligations contemplated in the contract other than those of CCI. Accordingly, CCI may but not limited to, accept contestants that may not be in strict compliance with age requirements.
